# Call for facilitator of short-term grantmaking opportunity



XIX: Shall Not Be Denied - Why it Matters Initiative

XIX: Shall Not Be Denied, a partnership of the Rhode Island Council for the Humanities and the Rhode Island Department of State, seeks a **facilitator of a new electoral initiative** to engage community members with voting, elections, and democratic participation through a series of public humanities programs.

Supported by the "Why it Matters: Civic and Electoral Participation" initiative, administered by the Federation of State Humanities Councils and funded by Andrew W. Mellon Foundation, this electoral initiative will build on the existing statewide civic engagement platform <a href="XIX: Shall Not Be Denied">XIX: Shall Not Be Denied</a>, which has successfully partnered with over 30 organizations in the past year to catalyze community awareness of the centennial of the 19th Amendment.

The current initiative will support seven grants of \$5,000 each for humanities projects connected to elections, voting, civic education, participatory democracy, and related media and communication that reach diverse audiences. The call for project proposals will be announced in December. The initiative will also support a series of programs that bring together policy, history, and culture to activate the State of Rhode Island's significant women's suffrage archive.

## **Description of position:**

The XIX: Shall Not Be Denied - Why it Matters Initiative Facilitator will work with staff from the Humanities Council and the Department of State to manage the website and coordinate the grant application process. The facilitator will communicate with applicants, including connecting them with resources and potential partners; provide branding and promotion for the initiative and associated events; coordinate the grant application, review, and award process; and help to manage analysis and evaluation of the initiative.

#### Schedule:

The facilitator will begin work in early December 2020 with a schedule averaging about 10 hours per week. The *XIX:* Shall Not Be Denied - Why it Matters Initiative will take place between December 2020 and April 2021. The majority of work will be conducted remotely. Any in-person activities will strictly adhere to COVID-19 guidelines established by the CDC and RIDOH.

# Stipend:

The facilitator position will be supported by a \$5,000 stipend.
